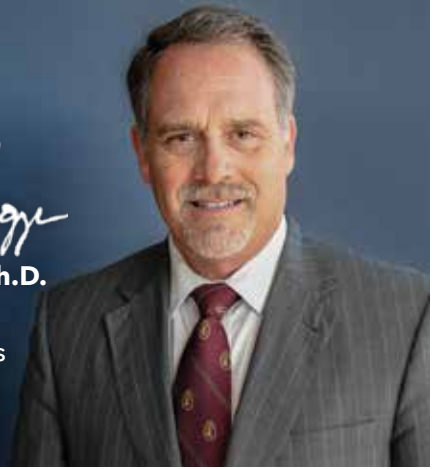

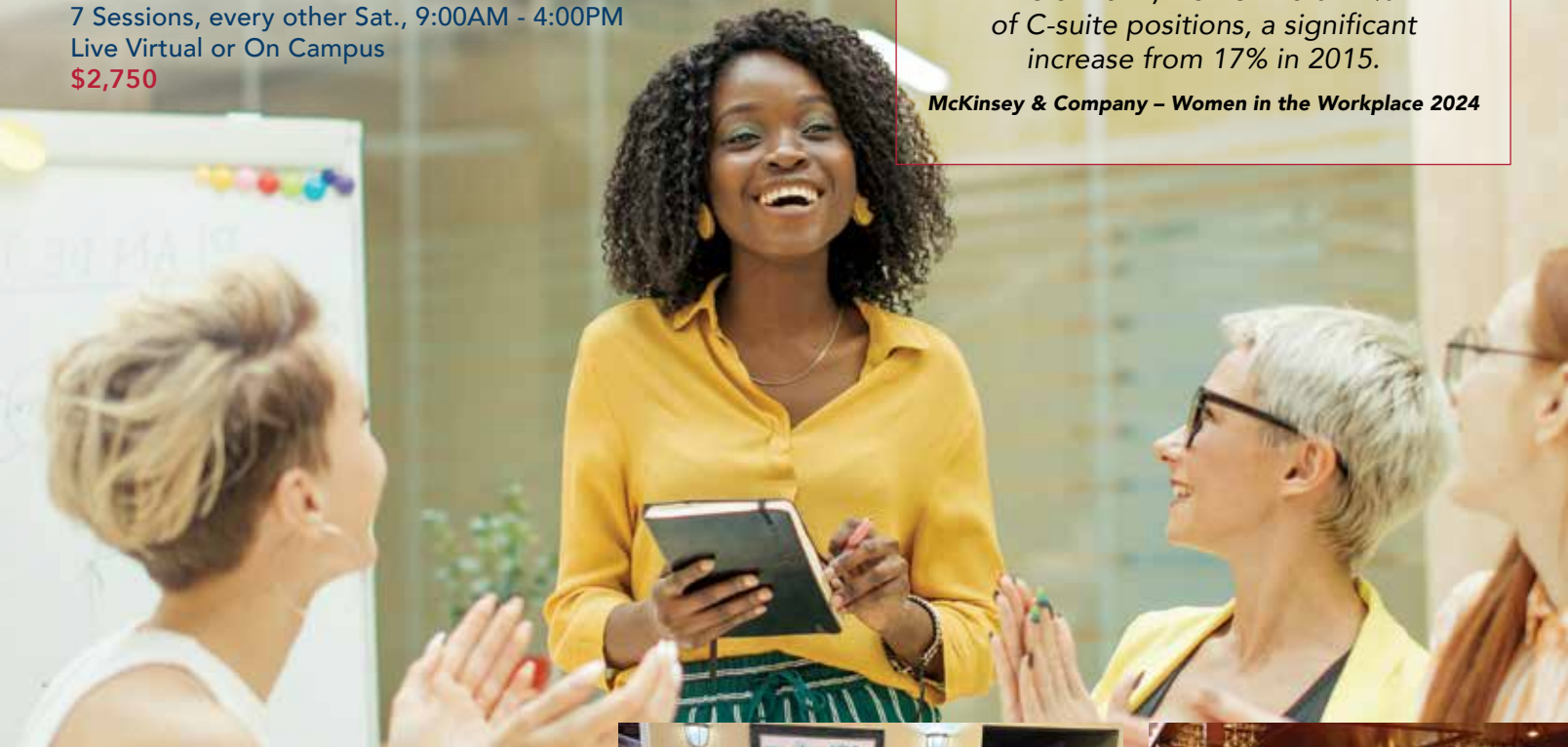

NAVIGATING UNCERTAINTY: THE ROLE OF GEOPOLITICAL ANALYSIS IN GLOBAL BUSINESS

Stability and predictability appear to be anomalies in today's world of international relations and trade. For several decades, businesses could and did largely expect a steady move toward more open trade, freer markets, and a common understanding of global regulations based largely on a Western liberal economic model. While at times this expectation seemed promising, a deeper look showed that only in times of common prosperity was it plausible - after several economic shocks, rising wealth differentials, and increasingly clear "winners" and "losers" in the international system, we have slid back into a more "normal" historic pattern, one where nationalism and economic protectionism go hand in hand with ideas of sovereignty (on land, at sea, in the air, and even in cyberspace) and national security. At the same time, transnational risks, from climate change and extreme weather to cybercrime and terrorism, continue to challenge nations even as countries seek more national, rather than international, solutions.

Understanding this complex system and the changes facing the international business community requires a way to weave together the different strands, from political risks to social changes, economic competition to technological disruptions. Applied geopolitical analysis is such a framework, one that seeks to understand the way a volatile global situation impacts the movement of goods, people, capital, and ideas across borders, and does so not merely from an explanatory fashion, but through a forward looking lens. By applying geopolitical methodologies, one can better anticipate - and adapt to - the ever-changing flow of future history.

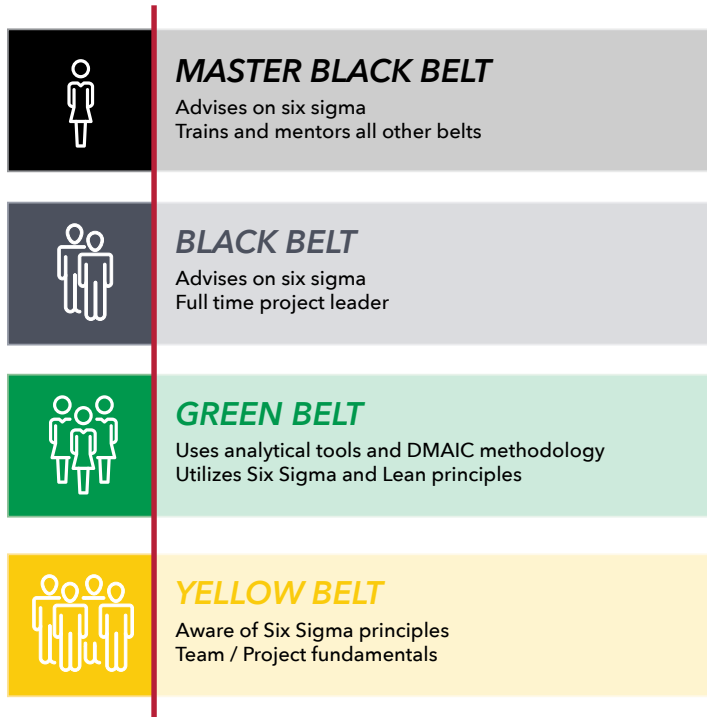

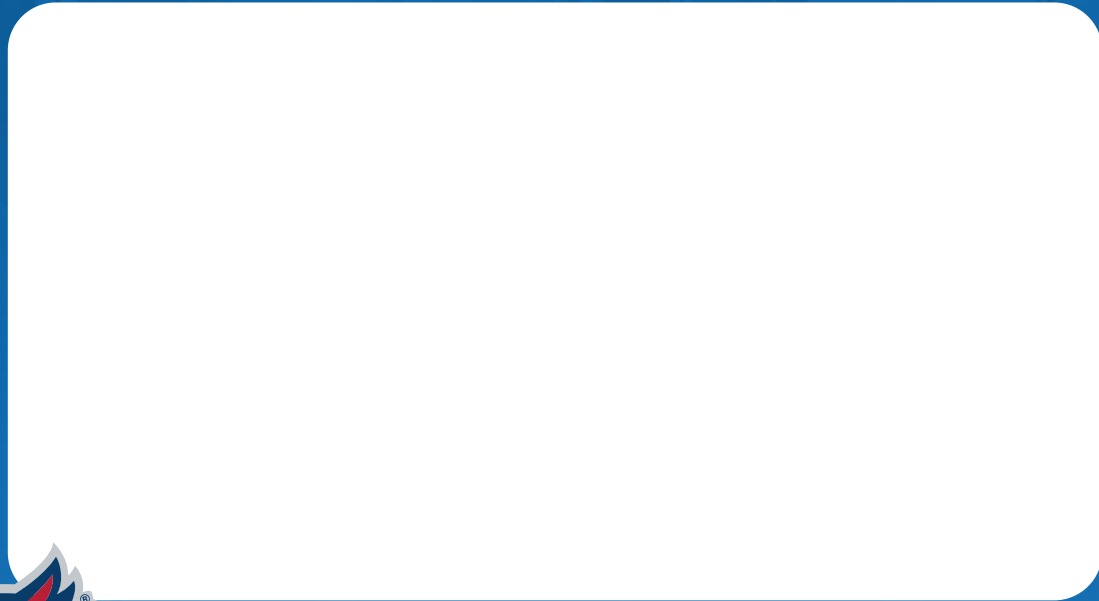
