STRATEGIC PLANNING COMMITTEE –John Valentine (Co-Chair)

- 1) Refine the COB Strategic Plan component of the AACSB report
- 2) Provide a forum for joint representation of faculty and administration interests in the development and assessment of ongoing strategic planning activities within the College of Business.

COB Graduate Council Goals (2012-2013) (Allen Smith-Chair)

- 1. Evaluate, recommend, process, and provide feedback to relevant faculty, department chairs, and administrators concerning requests and proposals related to College of Business graduate courses and programs, such as new course proposals, course change requests, requests for certificate programs, proposals for new tracks/concentrations, new degree programs, curriculum changes, degree requirements, admission requirements, and the like.
- 2 Consider and recommend academic-related policy for graduate programs offered by College of Business to the Dean of the College of Business.
- 3. Represent the College of Business at the University Programs Committee (UPC), the University Graduate Council (UGC), Graduate Grievance Committee, the University Senate, and the University Faculty Senate as required.
- 4. Report to affected College of Business department and administrators information, policies, issues, recommendations, and the like being discussed or recommended at the University Programs Committee and the University Graduate Council, including decisions about course and curriculum proposals brought by the COB Graduate Council to the UPC, UGC, and University Faculty Senate.
- 5. Direct faculty to University policies and forms relating to COB Graduate programs and courses.

P&T Committee (Pradeep Korgaonkar-Chair)

- 1. Advise the Dean on P and T of faculty colleagues;
- 2. Assist the college in development of promotional system for college instructors.

Undergraduate Council (Ethlyn Williams - Chair)

- 1. Support, consider, and recommend college initiatives/policies for program changes.
- 2. Provide information to faculty on University policies and forms relating to COB Undergraduate programs and courses
- 3. Provide feedback and support to departments, faculty and administrators in developing, proposing and processing curriculum changes, new programs/degrees, new courses or changes to existing courses, in order to facilitate their approval at the College and University level.
- 4. Provide representatives to the Undergraduate Programs Committee (UUPC) and support initiatives at the University that support College of Business programs and objectives.
- 5. Provide feedback on proposals, requests, changes at the UUPC.

Faculty Development Council (Andac Arikan-Chair)

- 1. Examine issues related to the proposed COB feedback reports on data from the Student Perception of Teaching assessments.
- 2. Support activities and initiatives of the Master Teacher committee.
- 3. Foster, support, and promote policies to enhance the quality of faculty development and work.
