## **Entrepreneurship PhD**

With its focus on Entrepreneurship, this PhD concentration at FAU provides the specialized preparation needed by nascent entrepreneurship scholars seeking to make significant contributions through their teaching and research. Early in the program our students are paired with at least one faculty mentor who shares their research interests. The program generally consists of two years of coursework, followed by comprehensive exams and a dissertation, and it usually takes a minimum of four years to complete.

Our students regularly present their research at prestigious conferences, and many have academic journal publications prior to graduation. Job placements are strong, with our students obtaining positions at universities nationwide.

## **Program Summary**

Full-time program requires 4 to 5 years in residency:

- 2 years of coursework consisting of core management seminars, research methods classes, and supporting courses
- Development and completion of research projects with publication potential
- Successful completion of comprehensive exams and defense of a doctoral dissertation

## **Financial Support**

Admitted students receive the following:

- \$38,000 annual stipend
- **Tuition waiver**
- Health insurance
- Travel reimbursement to attend conferences

In return for the stipend, students usually work as graduate assistants for department faculty during their first two years and then teach undergraduate classes beginning in their third vear.

## **Admission Requirements**

Admission to the PhD Program is restricted to students who show exceptionally high promise for mastering conceptual and analytical tools in business. While the minimum requirements are listed below, higher requirements may be used when there are numerous applicants with strong credentials.

#### **Previous Coursework**

- Minimum 3.5 GPA in master's program
- Minimum 3.0 GPA in undergraduate program
- A professional general evaluation is required for all international transcripts.

### **Graduate Management Admissions Test**

- A minimum score of 555 on the GMAT taken within the last five years.
- The GRE may be considered but the GMAT is preferred.

#### Letters of Recommendation

Three letters of recommendation are required. At least two of the letters should be from professors who can assess the applicant's potential for study at the PhD level.

#### **Statement of Career Goals**

The applicant should provide a statement (maximum length three pages) regarding why he or she wishes to pursue the PhD degree.

### **Language Requirements**

For applicants whose native language is not English, minimum scores of 600 on the TOEFL; 7.0 band score on the IELTS; or 90 on the Duolingo are required.
